President of the Commission for Protection of Competition, pursuant to Article 37, paragraph 2 of the Law on Protection of Competition (Official Journal of the RS", no. 51/09) and Article 2, paragraph 1, item 6 of the Tariff on the level of compensation for activities within the competency of the Commission for Protection of Competition ("Official Journal of the RS", no. 47/2011), deciding under application of concentration registered under no. 6/0-02-159/2012-1, jointly submitted, against enclosed power of attorney, by lawyers from Beograd, Beba Miletic, Maja Stankovic and Marina Bulatovic, all from law office Wolf Theiss, PC Ušće, Bulevar Mihajla Pupina 6, 11 070 Novi Beograd, on behalf of companies Varioform PET Verpackung Gasellschaft m.b.H., set up in line with laws of Austria, under registry no. FN 104017 t, with registered head-office located at 3134 Reichersdorf, Industriestrasse 5, Austria, company Boresona Ltd., set up in line with laws of Cyprus, under registry no. HE 84082, with registered head-office at Prodromou Avenue 75, Nicosia, Cyprus and company, Energoprojekt Industrija a.d. set up in line with laws of Serbia, under reference no. 07073224, with registered head-office at Bulevar Mihajla Pupina 12, Beograd Serbia, on March 6, 2012, issued a following

DECISION

I Concentration of market participants is approved in summary procedure created by acquisition of joint control by company Varioform PET Verpackung Gesellschaft m.b.H., set up in line with laws of Austria, under registry no. FN 104017 t, with registered head-office at 3134 Reichersdorf, Industriestrasse 5, Austria, company Boresona Ltd., set up in line with laws of Cyprus, under registry no. HE 84082, with registered head-office at Prodromou Avenue 75, Nicosia, Cyprus and company Energoprojekt Industrija a.d., set up in line with laws of Serbia under reference no. 07073224, with registered head-office at Bulevar Mihajla Pupina 12, Beograd, Serbia, over company Energo PET d.o.o. Beograd, set up in line with laws of Serbia, under reference no. 17165941, with registered

head-office at Bulevar Mihajla Pupina 12, Beograd, Serbia on the ground of purchase of share, by which ownership share in company Energo PET d.o.o. Beograd, as target company, shall be allocated between shareholders in such a way that company Varioform PET Verpackung Gesellschaft m.b.H. as a first member of target company shall hold 50,01% of share, company Energorprojekt Industrija a.d. as second member 33,33% and Boresona Ltd. as third member shall hold 16,66% of share.

II It is established that applicants of concentration effected payment, in prescribed time period, in the amount of 25.000,00 Euro to the foreign currency account of the Commission for Protection of Competition maintained with National Bank of Serbia, reference no. 6/0-02-159/2012-1, representing corresponding level of compensation for issuance of decision on approval of concentration in summary procedure referred to in Article 2, paragraph 1, item 6 of the Tariff on the level of compensation for activities within the competency of the Commission for Protection of Competition.
