President of the Commission for Protection of Competition, pursuant to Article 37, paragraph 2 of the Law on Protection of Competition ("Official Journal of the RS", no. 51/09) and Article 2, paragraph 1, item 6, of the Tariff on the level of compensation for activities within the competency of the Commission for Protection of Competition ("Official Journal of the RS" no. 47/2011), deciding under application of concentration entered under no.6/0-02-168/2012-1, submitted against power of attorney by lawyer Relja Zdravkovic from Beograd, law office Zdravkovic & Partners, lawyers partnership company located at Francuska 27, 11 000 Beograd, on behalf of client - company UNIPOL GRUPPO FINANZIARIO S.p.A., with registered head-office at Via Stalingrado 45, Bologna, Republic of Italy, ID 00284160371, on March 20, 2012 issued a following

DECISION

I Concentration of market participants in summary procedure is approved created by acquisition of direct control by Italian company UNIPOL GRUPPO FINANZIARIO S.p.A., with registered head-office at Via Stalingrado 45, Bologna, Republic of Italy ID 00284160371, over company PREMAFIN FINANZIARIA S.p.A. with registered head-office at Via Guido D, Arezzo, 2 CAP 00198, Roma, Republic of Italy, on the grounds of purchase of new issue of shares of this company resulting in acquisition of indirect control of company UNIPOL GRUPPO FINANZIARIO S.p.A., over companies held by target company, which are set up and operating in line with relevant regulations of the Republic of Serbia, they being SHAREHOLDING COMPANY FOR INSURANCE DDOR NOVI SAD, with registered head-office at Bulevar Mihajla Pupina 8, Novi Sad reference no. 08194815, DDOR AUTO DRUSTVO WITH LIMITED LIABILITY, with registered head-office at Bulevar Oslobođenja 127/XIV, reference no. 08781397 and DDOR RE SHAREHOLDING COMPANY FOR RE-INSURANCE, with registered head-office at Bulevar Mihajla Pupina 8, Novi Sad, reference no. 20598409.

II It is established that payment in the amount of 2.754.847,00 dinars was effected to the account of Commission for Protection of Competition maintained with Treasury within the Ministry of Finance, under reference no. 6/0-02-168/2012-1, representing corresponding dinar countervalue of defined level of compensation for issuance of decision on approval of concentration in summary procedure referred to in Article 2, paragraph 1, item 6 of the Tariff on the level of compensation for activities within the competency of the Commission for Protection of Competition, calculated by applying medium foreign currency rate of exchange at the date of payment.
