DECISION

I Concentration of market participants is approved in summary procedure created by acquisition of joint control, by Shareholding company Fabrika hartije for production of wood- free and wrapping materials Beograd, Prilazni put Ada Huji 9, Beograd entered into Agency for Companies Registry under ID 07006497, Company for production of cardboard products Avala Ada d.o.o. Beograd, Prilazni put Ada Huji 9, Beograd entered into Agency for Companies Registry under ID 07026129, Shareholding company Umka Fabrika kartona Umka, Trinaestog oktobra 1, Umka, entered into Agency for Companies Registry under ID 07007019, Shareholding company Jaffa, Fabrika biskvita Crvenka, Marsala Tita

II It is established that for issuance of act by the Commission approving implementation of concentration in summary procedure, applicant of concentration effected payment, in prescribed period, of RSD 2.628.955,00 to the account of Commission for Protection of Competition maintained with Treasury, within the Ministry of Finance no. 840-880668-16, reference no. 6/0-02-87/2012-1, representing dinar countervalue of corresponding level of compensation for issuance of decision on approval of concentration in summary procedure referred to in Article 2, paragraph 1, item 6 of the Tariff on the level of compensation for activities within the competency of Commission for Protection of Competition.
