On January 6, 2012, President of the Commission for Protection of Competition, pursuant to Article 37, paragraph 2 of the Law on Protection of Competition ("Official Journal of the RS", no. 51/09) and Article 2, paragraph 1, item 6, of Tariff on the level of compensation for activities within the competency of Commission for Protection of Competition ("Official Journal of the RS", no. 47/2011) deciding under notification of concentration no. 6/0-02-936/2011-1 submitted through proxy, lawyer Beba Miletic, from Beograd, Oblakovska 28, from law office Wolf Theiss, PC Usce, Bulevar Mihajla Pupina 6, 11070 Novi Beograd, by company Cooper Tire & Rubber Company, established in the state of Delaware, United States of America, with head-office at 701 Lima Avenue, Findly, OH 45840, on behalf of its subsidiary company in the Republic of Serbia – Cooper Tire & Rubber Company Serbia, company with limited liability founded in line with the laws of Serbia, with registered head-office at Svetog Save 4, 37000 Krusevac, Republic of Serbia, issued a following

Decision

I Concentration of market participants is approved in summary procedure created by acquisition of sole control by company with limited liability Cooper Tire & Rubber Company Serbia, incorporated in line with laws of Serbia, with head-office at Svetog Save 4, 37000 Krusevac, Republic of Serbia, and entered into Agency for Companies Registry under reference no. 20787708, over Factory for passenger vehicles tire with all pertaining company's assets, operating within Trajal Corporation a.d., with registered head-office at Milosa Obilica bb, Krusevac, Serbia, as a result of taking-over of target company and its pertaining assets by company Cooper Tire & Rubber Company Serbia, pursuant to and under conditions stipulated by the Purchase and Sales Agreement.

II It is established that the company Cooper Tire & Rubber Co., effected payment, in prescribed period, of EUR 25.000 to the foreign currency account of

Commission for Protection of Competition maintained with National Bank of Serbia, reference number 6/0-02-936/2011-1, representing corresponding level of compensation for issuance of decision on approval of concentration in summary procedure, referred to in Article 2, paragraph 1, item 6 of the Tariff on the level of compensation for activities within the competency of Commission for Protection of Competition, relating to control over Factory for passenger vehicles tire – Krusevac, with all its pertaining assets, which, until the completion of transaction, shall operate within Trajal Corporation a.d. Krusevac.
