Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, number 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, number 33/97, 31/01 and “Official Gazette of the RS”, number 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, number 49/11), deciding under the notification on concentration entered under number 6/0-02-713/2016-1, submitted by ABC Startside AS company, with registered seat at the address Kirkegata 17, 0153 Oslo, Kingdom of Norway, represented by plenipotentiary attorney Bojana Miljanović and other attorneys from the Law office Karanović and Nikolić aod, with registered seat at the address 23 Resavska Street, Belgrade, on December 5, 2016, the President of the Commission for Protection of Competition enacts the following

## **DECISION<sup>1</sup>**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct sole and independent control on the part of ABC Startside AS company, with registered seat at the address Kirkegata 17, 0153 Oslo, Kingdom of Norway, company registration number 980 176 185, and thus indirect sole and independent control of Telenor ASA company, with registered seat at the address Snarøyveien 30, 1360 Fornebu, Kingdom of Norway, company registration number 982 463 718, over targeted company ABC Tech Ltd., with registered seat at the address Unit 1101 and 1104, 11th Floor, Exchange Tower, 388 Sukhumvit Road, Bangkok 10110, Kingdom of Thailand, registered in the Commercial Registration Office of the Department of Business Development, Ministry of Commerce, with company registration number 0105552005651, established by the acquisition of 50% of shares and changing the joint into a sole and independent control.

**II IT IS ESTABLISHED** that ABC Startside AS company, with registered seat at the address Kirkegata 17, 0153 Oslo, Kingdom of Norway, has fully perfumed against its

commitment related to paying the determined amount of the fee as compensation for issuing this decision on November 28, 2016, by executing the payment in the total amount of EUR 25,000.00 (in words: twenty-five thousand Euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia.
