Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, number 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, number 33/97, 31/01 and “Official Gazette of the RS”, number 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, number 49/11), deciding under the notification on concentration entered under number 6/0-02-137/2017-1, submitted on January 13, 2017, by KKR & Co.L.P., from Delaware, United States of America, with registered headquarters at the address 9 West 57th Street, Suit 4200, New York 1019, USA, company registration number SRV 070749270-4378294, via plenipotentiary attorney Maja S. Stanković, with registered seat at the address 26 Njegoševa Street, Belgrade, on February 14, 2017, the President of the Commission for Protection of Competition enacts the following

DECISION¹

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of indirect control on the part of KKR & Co.L.P., from Delaware, United States of America, with registered headquarters at the address 9 West 57th Street, Suit 4200, New York 1019, USA, company registration number SRV 070749270-4378294, via its subsidiary company HK Holdings Co. Lt.d., with registered seat at the address 11F, Meiji Yasuda Seimei Building, 2-1-1 Marunouchi, Chiyoda-ku, Tokyo 100-0005 Japan, company registration number 0100-01-179628, over company Hitachi Koki Co. Ltd, established in accordance with the legislation of Japan, company registration number 0104-01-038697, with registered seat at the address Shinagawa Intercity Tower A, 20th Floor, 15-1, Konan 2-chome, Minato-ku, Tokyo 108-6020.
