Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, number 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, number 33/97, 31/01 and “Official Gazette of the RS”, number 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, number 49/11), deciding under the notification on concentration entered under number 6/0-02-760/2016-1, jointly submitted on November 7, 2016, by companies „Kiosk Grupa“ Ltd., with registered seat in Novi Sad at the address 1A Profesora Grčića Street, and natural persons Pavle Backović (unique personal identification number: 0306984710064) from Belgrade, Krnjača, 11v Zrenjaninski put Street, and Goran Popović (unique personal identification number: 2106971710195) from Belgrade, New Belgrade, 011D/64 Đorđa Stanojevića Street, via joint plenipotentiary attorney Vlasta Jovanović, with registered seat at the address 25 Svetog Save Street, Belgrade, on November 29, 2016, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct joint control on the part of company „Kiosk Grupa“ Ltd., with registered seat in Novi Sad at the address 1A Profesora Grčića Street, registered in the Business Registry Agency under company registration number 20847026, and natural persons Pavle Backović (unique personal identification number: 0306984710064) from Belgrade, Krnjača, 11v Zrenjaninski put Street, and Goran Popović (unique personal identification number: 2106971710195) from Belgrade, New Belgrade, 011D/64 Đorđa Stanojevića Street, over company „Corner Shop“ Ltd. with registered seat in Dobanovci at the address 206 Maršala Tita Street, registered in the Business Registry Agency under company registration number 20569417, by acquiring 100% share in the target company from previous owners of „Neregelia Trading Limited“ from Cyprus and „Nelt“ Ltd. from Belgrade.

II IT IS ESTABLISHED that applicants of notification on concertation have executed the payment in the amount of RSD 3,077,642.50 (in words: three million, seventy-seven thousand,

six hundred forty-two and five tenths Dinars) to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance, referencing number 6/0-02-760/2016-1, which represents determined RSD amount of the fee as compensation for issuing the decision on approval of concentration in summary procedure.
