Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, number 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, number 33/97, 31/01 and “Official Gazette of the RS”, number 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, number 49/2011), deciding under the Notification on concentration entered under number 6/0-02-730/2016-1 by SPIKA company, with registered seat at the address 23 rue Breschet, 63000 Clermont-Ferrand, France, and VILMORIN & CIE company, with registered seat at the address 4 quai de la Megisserie, 75001 Paris, France, submitted on October 19, 2016 via plenipotentiary Ana Banićević and other attorneys from the Law office “Harrison Solicitors”, with registered seat at the address 6 Mihajla Pupina Boulevard, BC Ušće/24<sup>th</sup> floor, Belgrade, on December 21, 2016, the President of the Commission for Protection of Competition enacts the following

## **DECISION<sup>1</sup>**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of SPIKA company, with registered seat at the address 23 rue Breschet, 63000 Clermont-Ferrand, France, registered in the Registrar of companies in Clermont-Ferrand under company registration number 304 690 209, and VILMORIN & CIE company, with registered seat at the address 4 quai de la Megisserie, 75001 Paris, France, registered in the Registrar of companies in Paris under company registration number 377 913 728, over EXOTIC SYSTEMS company, with registered seat at the address 29 rue Georges Besse, 63100 Clermont-Ferrand, France, registered in the Registrar of companies in Clermont-Ferrand under company registration number 494 964 091, established by acquisition of EXOTIC SYSTEMS’ shares.

**II IT IS ESTABLISHED** that applicants of notification on concertation have executed the payment in the amount of EUR 25,000.00 (in words: twenty-five thousand Euro) on October 27,
