Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, number 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, number 33/97, 31/01 and “Official Gazette of the RS”, number 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, number 49/11), deciding under the notification on concentration entered under number 6/0-02-650/2016-1, submitted by companies Trizma LLC, with registered seat at the address 272 Tošin bunar Street, Belgrade, Asseco SEE LLC, with registered seat at the address 19G Milutina Milankovića Street, Belgrade, Wise Engagement LLC, with registered seat at the address 9/5/51, 8 Marta Street, Belgrade, and New Frontier Innova LLC, with registered seat at the address 88 Omladinskih brigade Street, Belgrade, all represented via plenipotentiary attorneys Ana Gođevac and Darko Spasić, both with registered seat at the address at 73 Gospodar Jovanova Street, Belgrade, on November 1, 2016, the President of the Commission for Protection of Competition enacts the following

DECISION¹

I Concentration of undertakings in summary procedure **IS APPROVED** created by a joint venture on the part of companies: Trizma LLC, with registered seat at the address 272 Tošin bunar Street, Belgrade, with company registration number 17409042, Asseco SEE LLC, with registered seat at the address 19G Milutina Milankovića Street, Belgrade, with company registration number 07432451, Wise Engagement LLC, with registered seat at the address 9/5/51, 8 Marta Street, Belgrade, with company registration number 21029823, and New Frontier Innova LLC, with registered seat at the address 88 Omladinskih brigade Street, Belgrade, with company registration number 21119113, towards creating a new undertaking with limited liability capacity under business name Platiko, operating on a long-term basis and having all functions of an independent undertaking.

II IT IS ESTABLISHED that companies Trizma LLC, with registered seat at the address

272 Tošin bunar Street, Belgrade, has executed the payment in the amount of RSD 923,859.75 (in words: nine hundred twenty-three thousand, eight hundred fifty-nine and seventy-five hundredths Dinars), Asseco SEE LLC, with registered seat at the address 19G Milutina Milankovića Street, Belgrade, has executed the payment in the amount of RSD 923,859.75 (in words: nine hundred twenty-three thousand, eight hundred fifty-nine and seventy-five hundredths Dinars), Wise Engagement LLC, with registered seat at the address 9/5/51, 8 Marta Street, Belgrade, has executed the payment in the amount of RSD 307,953.25 (in words: three hundred seven thousand, nine hundred fifty-three and twenty-five hundredths Dinars), and New Frontier Innova LLC, with registered seat at the address 88 Omladinskih brigade Street, Belgrade, has executed the payment in the amount of RSD 923,859.75 (in words: nine hundred twenty-three thousand, eight hundred fifty-nine and seventy-five hundredths Dinars), totaling in RSD equivalent value to EUR 25,000.00 (in words: twenty-five thousand Euro) calculated at the National Bank of Serbia's middle exchange rate on the day of payment, September 26, 2016, thus executing in full their joint and several liability of paying amount of the fee as compensation for issuing the decision on approval of concentration in summary procedure to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance.
