Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-588/2016-1, submitted by companies KPNK Coöperatief UC, with registered seat at the address Amstelveenseweg 760, 1081 JK Amsterdam, the Netherlands, and Kopernikus Corporation LLC, with registered seat at the address Haaksberweg 71, 1101 BR Amsterdam, the Netherlands, represented by plenipotentiary Bojan Vučković and other attorneys from the Law office “Karanović and Nikolić” a.o.d., with registered seat at the address 23 Resavska Street, Belgrade, on September 1, 2016, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by establishing a joint control on the part of companies KPNK Coöperatief UC, with registered seat at the address Amstelveenseweg 760, 1081 JK Amsterdam, the Netherlands, company registration number 000034809384, Legal Entities and Partnerships Information Number (RSIN) 856421133, and Kopernikus Corporation LLC, with registered seat at the address Haaksberweg 71, 1101 BR Amsterdam, the Netherlands, company registration number 000035121025, RSIN 856585117, over Kopernikus Technology LLC Belgrade, with registered seat at the address 206 Jurija Gagarina Street, company registration number 17202057, created by acquiring 51% of shares by KPNK Coöperatief UC from the former sole member Kopernikus Corporation LLC that keeps 49% of shares.

II IT IS ESTABLISHED that company KPNK Coöperatief UC, with registered seat at the address Amstelveenseweg 760, 1081 JK Amsterdam, the Netherlands, via Abris CEE MID Market Fund III LP, with registered seat at the address at Elizabeth House, 9 Castle Street, St Helier Jersey, has fully performed against its obligation to pay determined amount of the fee as compensation for issuing this Decision on August 17, 2016, by executing payment in the total amount of EUR 25,000.00 (in words: twenty-five thousand Euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia.
