Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-466/2016-1, submitted on June 10, 2016 by company Nissan Motor Co. Ltd., with registered seat at the address No. 2, Takara-cho, Kanagawa-ku, Yokohama-shi, Kanagawa 220-8623 Japan, represented by plenipotentiary attorney Danijel Stevanović from the Law office “Moravčević, Vojnović i Partneri“ oad from Belgrade, 15 Dobračina Street, on July 15, 2016, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-474/2016-1 of June 14, 2016, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of company Nissan Motor Co. Ltd., with registered seat at the address No. 2, Takara-cho, Kanagawa-ku, Yokohama-shi, Kanagawa 220-8623 Japan, company registration number 0200-01-031109, over company Mitsubishi Motors Corporation, with registered seat at the address 33-8, Shiba 5-chome, Minato-ku, Tokyo 108-8410 Japan, company registration number 0104-01-029044, effected by purchasing 34% of ownership interest in the Mitsubishi Motors Corporation.

II IT IS ESTABLISHED that the applicant of notification has in timely manner executed payment of the fee as compensation for issuing acts of the Commission, by executing payment in the amount of EUR 12,500.00 (in words: twelve thousand, five hundred Euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, and RSD 1,549,413.75 (in words: one million, five hundred forty-nine thousand, four hundred thirteen and seventy-five hundredths Dinars) to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance, reference number 6/0-02-466/2016-1, which in total amounts to EUR 25,000.00 (in words: twenty-five thousand Euro) and corresponds to the determined amount of the fee as compensation for issuing the decision on approval of concentration in summary procedure
