Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-607/2016-1, submitted by company Telenor Maritime LLC, with registered seat at the address Nygaten 4, 4838 Arendal, Kingdom of Norway, represented by plenipotentiary Bojana Miljanović and other attorneys from the Law office “Karanović and Nikolić“ oad, with registered address at 23 Resavska Street, Belgrade, on September 12, 2016 President of the Commission for Protection of Competition enacts the following

**DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual direct control on the part of company Telenor Maritime LLC, with registered seat at the address Nygaten 4, 4838 Arendal, Kingdom of Norway, company registration number 985 173 710, and thus of indirect control on the part of company Telenor JSC, with registered seat at the address Snarøyveien 30, 1360 Fornebu, Kingdom of Norway, company registration number 982 463 718, over target company SatPoint LLC, with registered seat at the address Vretenvägen 10, 171 54 Solna, Stockholm, Kingdom of Sweden, company registration number 556630-4860, by acquiring 100% of stocks.

**II IT IS ESTABLISHED** that company Telenor Maritime LLC, with registered seat at the address Nygaten 4, 4838 Arendal, Kingdom of Norway, has fully performed against its obligation to pay determined amount of the fee as compensation for issuing this Decision, by executing payment in the amount of EUR 24,971.00 (in words: twenty-four thousand, nine hundred seventy-one Euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, on August 24, 2016, and additional amount of RSD 3,571.30 (in words: three thousand, five hundred seventy-one and three tenths Dinars) to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance, which represents RSD equivalent of EUR 29 (in words: twenty-nine Euro) calculated at the National Bank of Serbia's middle exchange rate on the day of payment, September 1, 2016.
