Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-255/2017-1, submitted on March 7, 2017 by company Jaffa fabrika biskvita LLC Crvenka, with registered seat at the address 245 Maršala Tita Street, Crvenka, Serbia, company registration number 08004684, via plenipotentiary, attorney Nataša Zavišin from the Law office “Zavišin, Semiz i Partneri” a.o.d., with registered seat at the address 18 Simina Street, Belgrade, on March 20, 2017, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of company Jaffa fabrika biskvita LLC Crvenka, with registered seat at the address 245 Maršala Tita Street, Crvenka, Serbia, company registration number 08004684, and thus of indirect individual control on the part of company Kappa Star Limited, with registered seat at the address Makariou III, 66, Cronos Court, Flat 73 1077, Lefkosia, Cyprus, company registration number HE 110010, Cyprus, over company Banini JSC Kikinda in liquidation, with registered seat at the address 5 Nikole Tesle Street, Kikinda, Serbia, company registration number 08161739, by acquiring the undischarged bankrupt as a legal entity.

II IT IS ESTABLISHED that the applicant of notification has executed the payment in the amount of RSD 1,855,334.40 (in words: one million, eight hundred fifty-five thousand, three hundred thirty-four and four tenths Dinars) on March 7, 2017, and additional amount of RSD

1,239,665.60 (in words: one million, two hundred thirty-nine thousand, six hundred sixty-five and six tenths Dinars) on March 8, 2017 to the account of the Commission for Protection of Competition maintained with the Treasury Administration, referencing the number 6/0-02-255/2017-1, which represents determined dinar-currency amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
