Pursuant to Article 22(2) of the Law on Protection of Competition ("Official Gazette of the RS", nos. 51/09 and 95/13), Article 192 of the Law on General Administrative Procedure ("Official Gazette of the FRY", nos. 33/97, 31/01 and "Official Gazette of the RS", no. 30/2010), and Article 2(1/2) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition ("Official Gazette of the RS", no. 49/2011), deciding under the request for individual exemption of restrictive agreement from prohibition submitted by companies Roaming Electronics LLC, with registered seat at the address 27L Triše Kaclerovića Street, Belgrade, and Mercator-S LLC, with registered seat at the address 50 Temerinski put Street, Novi Sad, jointly represented by attorney Mlađan Marjanović from Belgrade, 3/5 Skenderbegova Street, during the 70th Session held on July 8, 2016, Council of the Commission for Protection of Competition enacts the following

## DECISION1

**I** Restrictive agreement – Contract on Business Cooperation **IS EXEMPT FROM PROHIBITION**, concluded on December 23, 2015 between companies Roaming Electronics LLC, with registered seat at the address 27L Triše Kaclerovića Street, Belgrade, and Mercator-S LLC, with registered seat at the address 50 Temerinski put Street, Novi Sad, with annexes representing the integral part of the Contract, namely: Annex 1-Specification of products; Annex 2-Contract on purchase and sale; Annex 3-Specification of sales outlets, and Annex 2 of the Contract on purchase and sale, containing specific procurement conditions stipulated by this contract.

II Applicants of the request are obligated to act in full accordance with their statements given in the filings entered under numbers 4/0-03-317/2016-9 of May 19, 2016, and 4/0-03-317/2016-10 of June 8, 2016, when implementing agreement from Paragraph I of enacting terms hereof, Article 3 of the Contract on Business Cooperation and Article 2 of the Contract on purchase and sale.

- III PERIOD IS DETERMINED regulating individual exemption from prohibition of agreement Contract on Business Cooperation from Paragraph I of enacting terms hereof, in the duration of 5 (five) years from the day of submitting the request, that is from April 6, 2016.
- IV Commitment **IS ESTABLISHED** and **IS ORDERED** to the applicant of related request, that as the compensation fee for issuing this Decision, execute the payment set in the amount of the RSD equivalent of EUR 1,200.00 calculated at the National Bank of Serbia's middle exchange rate on the day of payment, to the account of the Commission for Protection of Competition number 40-0000000880668-16 maintained with the Treasury Administration, reference number 4/0-03-317/2016, no later than seven days from the day of receiving this Decision.
