Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-402/2016-1, submitted on May 16, 2016 by company Saint-Gobain Gradbeni Izdelki LLC, with registered seat at the address 68 Ljubljanska cesta Street, 1290 Grosuplje, Slovenia, company registration number 5848296000, represented by plenipotentiary attorney Danijel Stevanović from the Law office „Moravčević, Vojnović i Partneri“, with registered seat at the address 15 Dobračina Street, Belgrade, on June 13, 2016, President of the Commission for Protection of Competition enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of target business operations on the part of company Saint-Gobain Gradbeni Izdelki LLC, with registered seat at the address 68 Ljubljanska cesta Street, 1290 Grosuplje, Slovenia, registered in the Business Register of Slovenia under company registration number 5848296000, comprised of production inputs and sale of adhesives and mortars used in external thermal insulation composite systems of company Demit LLC, with registered seat at the address 77 Spodnja rečica Street, 3270 Laško, Slovenia, registered in the Business Register of Slovenia under company registration number 1972715000, from its previous owner Fragmat TIM LLC, with registered seat at the address 77 Spodnja rečica Street, 3270 Laško, Slovenia, as a seller.

**II IT IS ESTABLISHED** that the applicant of notification has in timely manner executed payment in the amount of EUR 24,916.04 (in words: twenty-four thousand, nine hundred sixteen and four hundredths Euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, and payed addition amount of RSD 10,354.61 (in words: ten thousand, three hundred fifty-four and sixty-one hundredths Dinars) to the account of the Commission for Protection of Competition maintained with the National Bank of Serbia, which in total represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
