Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the Notification on concentration entered under number: 6/0-02-403/2016-1, submitted on May 16, 2016 by company Synthos LLC, with registered seat at the address Chemików 1, 32-600 Oświęcim, Poland, via plenipotentiary attorney Nikola B. Poznanović from the Law office „Janković, Popović and Mitić“ from New Belgrade, 6 Vladimira Popovića Street, on June 21, 2016, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-474/2016-1 of June 14, 2016, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of company Synthos LLC, with registered seat at the address Chemików 1, 32-600 Oświęcim, Poland, founded in accordance with the legislation of Poland and registered in the Business Register of the District Court in Kraków, company registration number KRS 0000038981, over target business operations comprised of production and sale of expanded polystyrene of company INEOS Industries Holdings Limited, with registered seat at the address Hawkslease, Chapel Lane, Lyndhurst SO43 7FG, Hampshire, United Kingdom, registered in the Company Registration Office in Cardiff under company registration number 06958119, created by acquiring 100% of shares in its subsidiary company INEOS Styrenics European Holding Pvt. Ltd., with registered seat at the address Konijnenberg 63, 4825 BC Breda, the Netherlands, registered in the Netherlands Chamber of Commerce under company registration number 34223812, and by acquiring assets related to expanded polystyrene business operations of its also subsidiary company INEOS Styrenics International LLC, with registered seat at the address Avenue des Uttins 3, 1180 Rolle, Switzerland, company registration number CHE-112.373.632.

II IT IS ESTABLISHED that the applicant of Notification has executed payment in the amount of EUR 24,969 (in words: twenty-four thousand, nine hundred sixty-nine Euro) on May 19, 2016, to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, and amount of RSD 3,826.84 (in words: three thousand, eight hundred twenty-six and eighty-four hundredths Dinars) to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance, which in total represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
