Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the Notification on concentration entered under number: 6/0-02-157/2017-1 of January 24, 2017 submitted by companies Canada Pension Plan Investment Board, with registered seat at the address One Queen Street East, Suite 2500, Toronto, Ontario M5C 2W5, Canada, and ODSA Holdco Limited, with registered seat at the address Lemesou 77, Elia House, 2121 Nicosia, Cyprus, via plenipotentiary Danijel Stevanović and other attorneys from the Law office “Moravčević, Vojnović and Partners” from Belgrade, 15 Dobračina Street, and Bojana Miljanović and other attorneys from the Law office “Karanović and Nikolić” from Belgrade, 23 Resavska Street, on March 10, 2017, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-165/2017-3 of March 2, 2017, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by change of individual control performed by company ODSA Holdco Limited, with registered seat at the address Lemesou 77, Elia House, 2121 Nicosia, Cyprus, registered in Cyprus under company registration number HE 325610 (with 91% of shares) into joint two-member control performed by Canada Pension Plan Investment Board, with registered seat at the address One Queen Street East, Suite 2500, Toronto, Ontario M5C 2W5, Canada (with 48% of shares) and company ODSA Holdco Limited (with 48% of shares), over company GlobalLogic Holdings Limited, with registered seat at the address Aztec Group House, 11-15 Seaton Place, St Helier, Jersey JE4 0QH, registered in the Companies Registry of Jersey under company registration number 118060, created by

acquiring 48% of shares in company GlobalLogic Holdings Limited on the part of Canada Pension Plan Investment Board.

II IT IS ESTABLISHED that the applicant of Notification - Canada Pension Plan Investment Board has executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand Euro) on February 7, 2017, to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
