Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the Notification on concentration entered under number 6/0-02-874/2015-1, submitted on November 30, 2015 by company “MBA Miljković” LLC Belgrade, with registered seat at the address 181 Mihajla Pupina Boulevard, Belgrade – New Belgrade, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 09134719, via plenipotentiary attorney Siniša Brašanac from the Law office „Brašanac“, with registered seat at the address 80 Njegoševa Street, Belgrade, Republic of Serbia, on December 21, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of company “MBA Miljković” LLC Belgrade, with registered seat at the address 181 Mihajla Pupina Boulevard, Belgrade – New Belgrade, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 09134719, over company “Kijevo” LLC, with registered seat at the address 52-57 Oslobođenja Street, Belgrade – Rakovica, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 07072287, in manner where “MBA Miljković” LLC Belgrade will acquire 99.786% of shares in “Kijevo” LLC from company "Gruppo Adige Bitumi" S.P.A. (JSC), with registered seat at the address Mezzocorona (TN) Corso IV, Novembre 13/I, CAP 38016, Republic of Italy, company tax identification number 00681300224.

II IT IS ESTABLISHED that the applicant of Notification on concentration has executed payment in the amount of RSD 2,523,560.38 (in words: two million, five hundred twenty-three thousand, five hundred sixty and thirty-eight hundredths Dinars) to the account of the

Commission for Protection of Competition no. 840-00000880668-16 maintained with the Treasury Administration, with reference number 6/0-02-874/2015-1, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition.
