Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-379/2017-1 submitted on May 10, 2017 by company Nidec Corporation, with registered seat at the address 338 Kuzetonoshiro-cho, Minami-ku, Kyoto 601-8205, Japan, company registration number 1300-01-002387, represented by plenipotentiary Maja Stanković and other attorneys from the Law office “Wolf Theiss” from Belgrade, 6 Mihaila Pupina Boulevard, Belgrade, on May 29, 2017, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of indirect control on the part of company Nidec Corporation, with registered seat at the address 338 Kuzetonoshiro-cho, Minami-ku, Kyoto 601-8205, Japan, company registration number 1300-01-002387, via its subsidiary companies Nidec Europe B.V. (Pvt. Ltd.), with registered seat at the address P.J. Oudweg 4, 1314 CH Almere, the Netherlands, company registration number 08172600, and Nidec Americas Holding Corporation, with registered seat at the address 8050 West Florissant Avenue, St Louis, Missouri 63136, the United States of America, company registration number 5212204, over companies Secop Holding GmbH (LLC), with registered seat at the address Mads-Clausen-Straße 7, 24939 Flensburg, Germany, registered in the Business register of the local court in Flensburg under company registration number HRB 7279 FL, Secop s.r.o (LLC), with registered seat at the address Továrenská 49, 953 01 Zlaté Moravce, Slovakia, registered in the Business register of the local court in Nitra under section Sro, company registration number 13235/N, Secop Compressors (Tianjin) Co. Ltd., with

registered seat at the address Wuqing Development Zone No. 27, Kai Yuan Road, 301700 Tianjin, China, registered in the Market and Quality Supervision Administration of Tianjin under single social credit number 911202226630700694 and company registration number 120000400007202, and Secop Inc., with registered seat at the address 4000 Northfield Way, Suite 600, Roswell, Georgia, USA, registered in the State of Delaware, the United States of America, under single identification number 5288137, by acquiring 100% of shares in the said target companies.

II IT IS ESTABLISHED that the applicant of notification, company Nidec Corporation, with registered seat at the address 338 Kuzetonoshiro-cho, Minami-ku, Kyoto 601-8205, Japan, has executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand Euro) on May 15, 2017 to the account of the Commission for Protection of Competition, which corresponds to the determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
