Pursuant to Article 37(2) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (“Official Gazette of the FRY”, nos. 33/97, 31/01 and “Official Gazette of the RS”, no. 30/10), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the Notification on concentration entered under number: 6/0-02-189/2017-1 of February 2, 2017, submitted by Telecommunications company Telekom Srbija JSC, with registered seat at the address 2 Takovska Street, Belgrade, Republic of Serbia, via legal representative Predrag Čulibrk, Chief Executive Officer, on April 24, 2017, President of the Commission for Protection of Competition enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of control on the part of Telecommunications company Telekom Srbija JSC, with registered seat at the address 2 Takovska Street, Belgrade, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number: 17162543, over Company for designing and building information systems YUNET INTERNATIONAL LLC Belgrade, with registered seat at the address 35/III Dubrovačka Street, Belgrade, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number: 07789815, currently executed by Astra bank JSC Belgrade – in liquidation, with registered seat at the address 7 Mihaila Bogićevića Street, Belgrade, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number: 07489927, as a seller of the proprietary interest of 62.222% in equity of company YUNET INTERNATIONAL LLC Belgrade, purchased by Telekom Srbija JSC, Belgrade.

**II IT IS ESTABLISHED** that the applicant of Notification has executed payment in the amount of RSD 3,093,160.00 (in words: three million, ninety-three

thousand, one hundred sixty Dinars) on March 7, 2017, to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
