Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-467/2017-1 of June 29, 2017, submitted by company Telenor Norge AS, with registered seat at the address Snarøyveien 30, 1360 Fornebu, Kingdom of Norway, registered in the Brønnøysund Register Centre under company registration number 976 967 631, via plenipotentiary attorney Bojana Miljanović from the Law office „Karanović and Nikolić“, 23 Resavska St., Belgrade, on July 17, 2017, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual control on the part of company Telenor Norge AS, with registered seat at the address Snarøyveien 30, 1360 Fornebu, Kingdom of Norway, registered in the Brønnøysund Register Centre under company registration number 976 967 631, a wholly owned subsidiary of Telenor ASA, with registered seat at the address Snarøyveien 30, 1360 Fornebu, Kingdom of Norway, registered in the Brønnøysund Register Centre under company registration number 982 463 718, over company Ucom AS, founded and registered in accordance with the legislation of Norway with company registration number 982 050 928, and with registered seat at the address Hillevågsvien 24, 4016 Stavanger, Rogaland, Norway, created by acquiring the entirety of the share capital of Ucom AS on the part of Telenor Norge AS.

II **IT IS ESTABLISHED** that the applicant of notification, company Telenor Norge AS, with registered seat at the address Snarøyveien 30, 1360 Fornebu, Kingdom of Norway, has executed payment in the amount of EUR 24,971.00 (in words: twenty-four thousand, nine hundred seventy-one euro) on July 5, 2017, and additional amount of RSD 3,487.50 (in words: three thousand, four hundred eighty-seven and five tenths dinars) on July 12, 2017, to the account of the Commission for Protection of Competition, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
