Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-548/2017-1 of August 8, 2017, submitted on the part of company Mainsee 1072. V V GmbH, with registered seat at the address Frankfurter Straße 85, 65239 Hochheim am Main, Germany, registered in the commercial register of local court in Frankfurt am Main, Germany, under company registration number HRB 108343, via plenipotentiary attorney Bojan Vučković from the Law office Karanović & Nikolić Beograd, 23 Resavska St., on September 7, 2017, President of the Commission for Protection of Competition enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual control on the part of company Mainsee 1072. V V GmbH, with registered seat at the address Frankfurter Straße 85, 65239 Hochheim am Main, Germany, registered in the commercial register of local court in Frankfurt am Main, Germany, under company registration number HRB 108343 (whose name will be changed prior to the closure of transaction into Tetra Pak Processing Equipment GmbH), which is in exclusive (100%) ownership of company Tetra Laval Holdings B.V., over the entirety of operative assets of company Big Drum Engineering GmbH, with registered seat at the address Anraffer Straße 2, 34549 Edertal, Germany, registered in the commercial register of local court in Fritzlar, Germany, under company registration number HRB 11790, created by acquisition of the entirety of operative assets of company Big Drum Engineering GmbH on the part of company Mainsee 1072. V V GmbH, subsidiary to Tetra Laval group.

**II IT IS ESTABLISHED** that the applicant of notification, company Mainsee 1072. V V GmbH with registered seat at the address Frankfurter Straße 85, 65239 Hochheim am Main, Germany, has executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand and 00/100 euro) via its plenipotentiary attorney on August 21, 2017, to the account of the Commission for Protection of Competition, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
