Pursuant to Article 37(2) , Article 65(5) of the Law on Protection of Competition (“Official Gazette of the RS”, nos. 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, no. 49/11), deciding under the notification on concentration entered under number 6/0-02-356/2017-1 submitted on April 25, 2017 by company Nidda Healthcare Holding AG (JSC), with registered seat at the address Maximilianstr. 11, 80539 Munich, German Federal Republic, registered in the Commercial Register of the local court in Munich under company registration number HRB 231228, via plenipotentiary attorney Bojan Vučković from the Law office „Karanović and Nikolić“ from Belgrade, 23 Resavska St., on May 29, 2017, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of funds managed by Bain Capital Investors LLC, with registered seat at the address 200 Clarendon Street, Boston, MA 02116, United States of America, and funds managed by Cinven Capital Management (VI) Limited Partnership Incorporated, via its general partner, Cinven Capital Management (VI) General Partner Limited, with registered seat at the address East Wing, Trafalgar Court, Les Banques, St. Peter Port, Guernsey GY 1 3 PP, via their jointly managed company Nidda Healthcare Holding AG (JSC) with registered seat at the address Maximilianstr. 11, 80539 Munich, German Federal Republic, registered in the Commercial Register of the local court in Munich under company registration number HRB 231228, over company Stada Arzneimittel AG (JSC), with registered seat at the address Stadastrasse 2-18, 61118 Bad Vilbel, German Federal Republic, registered in the

Commercial Register of the local court in Frankfurt am Main under company registration number HRB 71290.

II IT IS ESTABLISHED that the applicant of notification, company Nidda Healthcare Holding AG (JSC) with registered seat at the address Maximilianstr. 11, 80539 Munich, German Federal Republic, has via its plenipotentiary payed determined amount of the fee as compensation for issuing this decision in the amount of RSD 3,077,297.50 (in words: three million, seventy-seven thousand, two hundred ninety-seven and five tenths Dinars) on May 9, 2017 to the account of the Commission for Protection of Competition, which corresponds to the determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
