Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (Official Gazette of the FRY 33/97 and 31/01, and Official Gazette of the RS 30/2010), Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), and Article 13(2) of the Statute of the Commission for Protection of Competition (Official Gazette of the RS 49/2010), deciding under the notification on concentration entered under number 6/0-02-685/2015-1 of September 15, 2015, submitted by company „SIJ-Slovenska industrija jekla“ d.d., registered in the Business Register maintained by the Agency for Public Legal Records and Related Services of the Republic of Slovenia under company registration number 5046432000, with registered set in Ljubljana at the address 98 Gerbičeva St., in accordance with the power of attorney submitted by Milica Subotić and Nikola Poznanović, attorneys at law from the Law Office “Janković, Popović & Mitić” from Belgrade, 6 Vladimira Popovića St., on October 5, 2015, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-554/2015-4 of October 1, 2015, enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of company „SIJ-Slovenska industrija jekla“ d.d., registered in the Business Register maintained by the Agency for Public Legal Records and Related Services of the Republic of Slovenia under company registration number 5046432000, with registered set in Ljubljana at the address 98 Gerbičeva St., over company „Perutnina Ptuj“ d.d., registered in the Business Register maintained by the Agency for Public Legal Records and Related Services of the Republic of Slovenia under company registration number 5141966000, with registered seat in Ptuj at the address 10 Potrčeva cesta St., by acquiring shares in the recapitalization procedure of the target company and by acquiring remaining shares from its previous owners and minority shareholders.

**II IT IS ESTABLISHED** that the applicant of notification has in timely manner executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand and 00/100 euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, with reference number 6/0-02-685/2015-1, which represents determined amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
