Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/2009 and 95/2013, hereinafter referred to as the Law) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-100/2015-1 of January 22, 2015, submitted on behalf of clients - company ArcelorMittal Distribution Solutions Italia S.R.L., with registered seat at the address Viale Brenta 27/29, 20139 Milan, Italy, registered in the Business register of the Chambers of Commerce, Industry, Craftsmanship and Agriculture of Milan under company registration number MI-1795155, and company C.L.N. – Coils Lamiere Nastri S.P.A., with registered seat at the address Corso Susa 13/15, 10040 Caselette, Italy, registered in the Business register of the Chambers of Commerce, Industry, Craftsmanship and Agriculture of Torino under company registration number 00521230011, in accordance with the presented Power of attorney by Raško Radovanović, attorney at law from Belgrade, 3 Cincar Jankova St., on February 20, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of company ArcelorMittal Distribution Solutions Italia S.R.L., with registered seat at the address Viale Brenta 27/29, 20139 Milan, Italy, registered in the Business register of the Chambers of Commerce, Industry, Craftsmanship and Agriculture of Milan under company registration number MI-1795155, and company C.L.N. – Coils Lamiere Nastri S.P.A., with registered seat at the address Corso Susa 13/15, 10040 Caselette, Italy, registered in the Business register of the Chambers of Commerce, Industry, Craftsmanship and Agriculture of Torino under company registration number 00521230011, with the goal of creating a new undertaking, company ArcelorMittal CLN Distribuzione Italia S.R.L, operative on a long-term basis and holding all functions of an independent undertaking, where its founders will have a joint control within the meaning of Article 17(1/3) of the Law.

II IT IS ESTABLISHED that applicants have in timely manner executed payment in the amount of EUR 12,456.00 (in words: twelve thousand, four hundred fifty-six euro) and EUR 12,500.00 (twelve thousand, five hundred euro) to the foreign-currency account of the Commission

for Protection of Competition maintained with the National Bank of Serbia, as well as payment in the amount of RSD 5,430.16 (in words: five thousand, four hundred thirty and 16/100 dinars) to the dinar-currency account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance of the Republic of Serbia, with reference number 6/0-02-100/2015, which in total represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
