Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13, hereinafter referred to as the Law) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under the reception number 6/0-02-834/2014-1 (new number 6/0-02-11/2015) of December 29, 2014, submitted on behalf of the client – Limited liability company „Horizon Energy“ d.o.o. Šimanovci, with registered seat at the address bb Krnješevačka St., Šimanovci, Republic of Serbia, by attorneys at law Nikola Poznanović and Jelena D. Stanković from Belgrade, 6 Vladimira Popovića St., on January 26, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual control on the part of Limited liability company „Horizon Energy“ d.o.o. Šimanovci, with registered seat at the address bb Krnješevačka St., Šimanovci, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 20964812, over the Petrol station in Veliki Crljeni, bb Race Terzića St., acquired with the accompanying real-estate – property (buildings) and land on the cadastral plot number 1530/5 CM Veliki Crljeni, entered into the Real estate folio in the land register under number 2255 of CM Veliki Crljeni, as well as over the accompanying petrol station equipment for motor vehicle petrol supply purposes, and movable property for petrol station operations, created pursuant to the implementation of the planned sale and purchase in accordance with the Letter of intent for asset purchase concluded on December 24, 2014, wherewith company „Horizon Energy“ d.o.o. acquires the subject of sale and purchase from company „RR-Graditelj export-import d.o.o Lazarevac“, as a previous owner of the subject concerned.

II IT IS ESTABLISHED that the applicant of notification has in timely manner executed payment in the amount of RSD 3,026,202.50 (in words: three million, twenty-six thousand, two hundred two and 50/100 dinars) to the dinar-currency account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance, with reference number 6/0-02-834/2014-1, which represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
