Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-198/2015-1, submitted on behalf of company "CRH PLC", with registered seat at the address 42 Fitzwilliam Square, Dublin 2, Ireland, company registration number 12965, in accordance with the presented Power of attorney of February 18, 2015 by attorney at law Petronijević Srđana from the Law Office "Moravčević Vojnović & Partneri", 10 Dobračina St., Belgrade, Republic of Serbia, on March 23, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of indirect control on the part of company "CRH PLC", with registered seat at the address 42 Fitzwilliam Square, Dublin 2, Ireland, company registration number 12965, over the following companies: "Holcim (Srbija)" D.O.O., with registered seat at the address bb Popovac, Paraćin, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 07112904, "Agg Proizvodnja" D.O.O., with registered seat at the address bb Popovac, Paraćin, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 20436921, "Holcim Agregati" A.D., with registered seat at the address bb Popovac, Paraćin, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 08113157, and "Ecorec" D.O.O., with registered seat at the address bb Popovac, Paraćin, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 20144521, in a manner where company "CRH PLC" [...] ¹ will acquire shares in the said companies from "Holcim Ltd", with registered seat at the address Zurcherstrasse 156, 8645 Jona, Kantons St. Gallen, Switzerland, registered in the Commercial Register of the Canton of St. Gallen under company registration number CHE – 100.136.893.

II IT IS ESTABLISHED that the applicant of notification on concertation has executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand and 00/100 euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, with reference number 6/0-02-198/2015-1, which represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
