Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/2009 and 95/2013, hereinafter referred to as the Law) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-757/2014-1 of December 2, 2014, submitted on behalf of clients – company „Telenor Digital AS“, with registered seat at the address Snarøyveien 30, N-1331 Fornebu, Kingdom of Norway, registered in the Registration Center Brønnøysund under company registration number 996516288, and company „Schibsted Vekst AS“, with registered seat at the address Apotekergaten 10, NO-0105 Oslo, Kingdom of Norway, registered in the Registration Center Brønnøysund under company registration number 996249123, in accordance with the presented Power of Attorney by Bojan Vučković, attorney at law from the Law Office „Karanović & Nikolić“ from Belgrade, 23 Resavska St., on January 8, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of company „Telenor Digital AS“, with registered seat at the address Snarøyveien 30, N-1331 Fornebu, Kingdom of Norway, registered in the Registration Center Brønnøysund under company registration number 996516288, and company „Schibsted Vekst AS“, with registered seat at the address Apotekergaten 10, NO-0105 Oslo, Kingdom of Norway, registered in the Registration Center Brønnøysund under company registration number 996249123, over a newly-founded company „SoBazaar ANS“, where its founders will execute a joint control within the meaning of Article 17(1/3) of the Law.

II IT IS ESTABLISHED that applicants have in timely manner executed payment in the amount of EUR 24,973.00 (in words: twenty-four thousand, nine hundred seventy-three and 00/100 euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, as well as payment in the amount of RSD 3,268.30 (in words: three thousand, two hundred sixty-eight and 30/100 dinars) to the dinar-currency account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance of the Republic of Serbia, with reference number 6/0-02-757/2014, which in total represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
