Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13, hereinafter referred to as the Law) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-325/2015-1, submitted on behalf of Limited liability company „Al Dahra International Investment LLC“, with registered seat at the address Al Ain Tower 7th Floor, Khalidya – P.O. Box 130455, Abu Dabi, UAE, registered with the Department of Economic Development, UAE Ministry of Economy under company registration number CN-1195188, in accordance with the presented Power of attorney by Goran Martinović, Jelena Adamović and Jovan Ćirković, attorneys at law from Belgrade from the Law Office „Harrisons-solicitors“, with registered seat at the address 6 Mihajla Pupina Boulevard, BC Ušće, 24th Floor, on May 5, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual control on the part of Limited liability company „Al Dahra International Investment LLC“, founded and operative in accordance with the legislation of the United Arab Emirates, with registered seat at the address Al Ain Tower 7th Floor, Khalidya – P.O. Box 130455, Abu Dabi, UAE, registered with the Department of Economic Development, UAE Ministry of Economy under company registration number CN-1195188, over company „Al Dahra Rudnap“ d.o.o. Beograd, founded and operative in accordance with the legislation of the Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 20567872, with registered seat at the address 14 Admirala Geprata St., Belgrade, Republic of Serbia, created pursuant to the contractual takeover offer of 49% of shares in company „Al Dahra Rudnap“ d.o.o. Beograd executed on the part of the Acquirer from company „Rudnap Group“ A.D., in a manner where company „Al Dahra International Investment LLC“ with current shareholder interest in the target company of 51% becomes owner of 100% of share interests in company „Al Dahra Rudnap“ d.o.o..

II IT IS ESTABLISHED that the applicant has in timely manner and in the full amount executed payment of the fee as compensation for issuing this decision in the amount of RSD 3,000,360.00 (in words: three million, three hundred sixty and 00/100 dinars) to the dinar-currency account of the Commission for Protection of Competition no. 840-000000880668-16

maintained with the Treasury Administration of the Ministry of Finance of the Republic of Serbia, with reference number 6/0-02-325/2015-1, which represents appropriate dinar-currency equivalent value of the regulated fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition, calculated at the middle exchange rate of the National Bank of Serbia on the day of payment.
