Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/2009 and 95/2013, hereinafter referred to as the Law) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-329/2015-1 of April 16, 2015, jointly submitted on behalf of Matijević Group by affiliated companies, namely: Company for production and trade „Industrija mesa Matijević“ d.o.o. from Novi Sad, registered in the Business Registers Agency of the Republic of Serbia under company registration number 08588759, with registered seat in Novi Sad at the address 86 Rumenački put St., via legal representative Acting CEO Branka Grubor, and Company “MPZ-Agrar” d.o.o. from Novi Sad, registered in the Business Registers Agency of the Republic of Serbia under company registration number 21027146, with registered seat in Novi Sad at the address 86 Rumenački put St., via legal representative CEO Željko Radanović, on May 15, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of exclusive control on the part of companies operative within Matijević Group, namely: Company for production and trade „Industrija mesa Matijević“ d.o.o. from Novi Sad, with registered seat at the address 86 Rumenački put St., registered in the Business Registers Agency of the Republic of Serbia under company registration number 08588759, over company “Dijamant-Agrar” d.o.o., with registered seat in Zrenjanin at the address 14 Temišvarski drum St., registered in the Business Registers Agency of the Republic of Serbia under company registration number 08626553, as well as by acquisition of exclusive control on the part of company “MPZ-Agrar” d.o.o. from Novi Sad, with registered seat at the address 86 Rumenački put St., registered in the Business Registers Agency of the Republic of Serbia under company registration number 21027146, over company “Glogonj-Agrar” d.o.o. from Belgrade, with registered seat at the address bb Zrenjaninski put St., registered in the Business Registers Agency of the Republic of Serbia under company registration number 21094706.

II IT IS ESTABLISHED that applicants of notification and acquirers of control in the concentration concerned have in timely manner executed payment of the fee as compensation for issuing this decision of the Commission on approving implementation of concentration in summary procedure in the amount of RSD 3,003,500.00 (in words: three million, three thousand, five

hundred and 00/100 dinars) to the account of the Commission for Protection of Competition maintained with the Treasury Administration, no. 840-880668-16 with reference number 6/0-02-329/2015-1, which is in accordance with the regulated fee from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
