Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13, hereinafter referred to as the Law) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-368/2015-1 of April 29, 2015, jointly submitted on behalf of applicants by attorney at law Nataša Zavišin from Belgrade, 18 Simina St., on behalf of the party - company Belgrade Waterfront Capital Investment LLC, founded in accordance with the legislation of the United Arab Emirates, [...] ¹, and State Attorney Snježana Prodanović, 22-26 Nemanjina St., Belgrade, acting on behalf of the Republic of Serbia, authorized by direct implementation of Article 11 of the Law on Public Attorney's Office (Official Gazette of the RS 55/2014) to represent interests of the Republic of Serbia in this case, on May 27, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by the change of a form of control over company Beograd na vodi d.o.o. Beograd, founded in accordance with the legislation of the Republic of Serbia, with registered seat at the address 48 Karađorđeva St., Belgrade, Republic of Serbia, registered under company registration number 21033391, transformed from the individual form of control over company Beograd na vodi d.o.o. Beograd, executed by the Republic of Serbia as its previous sole shareholder and owner with 100% of share interests in this company, into jointly executed control which will be effected following the implementation of concentration over company Beograd na vodi d.o.o. Beograd pursuant to the ownership of 68% of share interests by company Belgrade Waterfront Capital Investment LLC, established in accordance with the legislation of the United Arab Emirates, [...] and the Republic of Serbia, which will participate in the total ownership share structure in company Beograd na vodi d.o.o. Beograd with co-ownership of 32%.

II IT IS ESTABLISHED that payment in the amount of EUR 25,000.00 (in words: twenty-five thousand euro) has been executed in timely manner to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, which

represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
