Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the Notification on concentration entered under number: 6/0-02-432/2015-1 of May 27, 2015, submitted by company ANTENNA STREAM T.V. LIMITED, with registered seat at the address Kostaki Pantelidi, 1, Kolokasides Building, 3rd floor, 1010, Nicosia, Republic of Cyprus, founded in accordance with the legislation of the Republic of Cyprus and registered in the Department of Registrar of Companies and Official Receiver of the Ministry of Energy, Commerce, Industry and Tourism of the Republic of Cyprus under company registration number HE 121728, via attorney at law Predrag Groza from the Law Office of Tomić Sinđelić Groza from Belgrade, 3/II Carice Milice St., on July 15, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of company ANTENNA STREAM T.V. LIMITED, with registered seat at the address Kostaki Pantelidi, 1, Kolokasides Building, 3rd floor, 1010, Nicosia, Republic of Cyprus, founded in accordance with the legislation of the Republic of Cyprus and registered in the Department of Registrar of Companies and Official Receiver of the Ministry of Energy, Commerce, Industry and Tourism of the Republic of Cyprus under company registration number HE 121728, over company LAKE BADE HOLDINGS LIMITED, with registered seat at the address Prodromou & Zinonos Kitieos 2, PALACEVIEW HOUSE, 2064, Nicosia, Republic of Cyprus, founded in accordance with the legislation of the Republic of Cyprus and registered in the Department of Registrar of Companies and Official Receiver of the Ministry of Energy, Commerce, Industry and Tourism of the Republic of Cyprus under company registration number HE 264084, created by acquiring 100% of shares in the said company.

II IT IS ESTABLISHED that the applicant of notification on concentration has executed payment of the fee as compensation for issuing this decision of the Commission on approval of concentration in summary procedure in the amount of EUR 19,781.10 (in words: nineteen thousand, seven hundred eighty-one and 10/100 euro) on May 27, 2015, and EUR 5,218.90 (in words: five thousand, two hundred eighteen and 90/100 euro) on July 1, 2015, to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, which in total represents determined amount of the fee from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
