Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under the reception number 6/0-02-521/2015-1 of June 29, 2015, submitted on behalf of the client company - „OTP Banka Srbija a.d. Novi Sad“, registered in the Business Registers Agency of the Republic of Serbia under company registration number 08603537, with registered seat at the address 80 Oslobođenja Boulevard, Novi Sad, Republic of Serbia - in accordance with the submitted Power of attorney, via attorneys at law Mihajlo Prica, Darija Ognjenović, Tijana Lalić and Iva Popović, all from the Law Office of Prica i partneri, 20 Kosančićev venac St., Belgrade, on July 15, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of individual control on the part of company „OTP Banka Srbija a.d. Novi Sad“, registered in the Business Registers Agency of the Republic of Serbia under company registration number 08603537, with registered seat at the address 80 Oslobođenja Boulevard, Novi Sad, Republic of Serbia, over company „Findomestic Banka a.d. Beograd“, with registered seat at the address 115A Mihaila Pupina Boulevard, Belgrade – New Belgrade, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 17076841, created by executing a contractual takeover of the entire share capital of company „Findomestic Banka a.d. Beograd“, pursuant to the Sale and purchase agreement concluded between the buyer and seller of the share capital concerned.

II IT IS ESTABLISHED that the applicant of notification on concentration has in timely manner executed payment in the amount of RSD 3,015,105.00 (in words: three million, fifteen thousand, one hundred five and 00/100 dinars) to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance of the Republic of Serbia, with reference number 6/0-02-521/2015-1, which represents determined amount of the fee calculated on the day of payment as a compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
