Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13, hereinafter referred to as the Law) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification on concentration entered under number 6/0-02-99/2015-1 of January 22, 2015, submitted by Company for research, production, processing, distribution and trade of oil and oil derivatives and research and production of natural gas “Naftna industrija Srbije a.d.” Novi Sad, with registered seat at the address 12 Narodnog fronta St., 21000 Novi Sad, Republic of Serbia, via authorized representative Saša Miletić, Project Manager, with registered residence at the address 050 Dušanova St., Sokobanja, U-PIN: 1504972753728, on February 18, 2015, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of Company for research, production, processing, distribution and trade of oil and oil derivatives and research and production of natural gas “Naftna industrija Srbije a.d.” Novi Sad, with registered seat at the address 12 Narodnog fronta St., 21000 Novi Sad, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company registration number 20084693, over a petrol station in Leštane, built on the cadastral plot number 346/1, CM Leštane, with the total surface area of 3,032, and entered into the Real estate folio in the land register under number 468, CM Leštane, created pursuant to the implementation of the Business and Technical Cooperation Agreement concluded on January 12, 2015 between company “Naftna industrija Srbije a.d.” Novi Sad as a lessee of the petrol station, and Company for trade and services “Emporio petrol” d.o.o., with registered seat at the address 26 Kružni put St., Belgrade – Grocka, company registration number 20585242, as a previous control holder over the petrol station in Leštane.

II IT IS ESTABLISHED that company “Naftna industrija Srbije a.d.” Novi Sad, with registered seat at the address 12 Narodnog fronta St., 21000 Novi Sad, Republic of Serbia, acting in the capacity of an applicant of notification and acquirer of control over the target facility, has in timely manner and in the full amount executed payment of the regulated amount of fee as

compensation for issuing this decision on January 23, 2015, by paying amount of RSD 3,065,190.00 (in words: three million, sixty-five thousand, one hundred ninety and 00/100 dinars) to the account of the Commission for Protection of Competition no. 840-0000000880668-16, maintained with the Treasury Administration of the Ministry of Finance of the Republic of Serbia, with reference number 6/0-02-99/2015-1, which represents appropriate dinar-currency equivalent value of the regulated amount of fee as compensation for issuing approval on concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition, calculated at the middle exchange rate of the National Bank of Serbia on the day of payment.
