Pursuant to Article 62 and 22 of the Law on Protection of Competition (Official Gazette of the RS 51/09), Article 2(1/7) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), and the Decision of the Commission Council no. 1/0-06-332/2013-4 of May 29, 2013, on the election of person to exert authorities of the Chairperson of the Commission Council, deciding in *ex officio* proceedings for investigation of concentration implemented by company „Autoritas Investments“ d.o.o. Novi Sad, with registered seat at the address 41 Kosovska St., registered in the Business Registers Agency of the Republic of Serbia under company number 20432730, represented by Željko Marović, Jelica Janjušević, Dr. Darinka Nedeljković, Sonja Đajić and Jelena Vujović, attorneys at law from Novi Sad, 82/III Oslobođenja Blvd., and LL.B. Miloš Andrović from Belgrade, 11 Nikšićka St. pursuant to the presented Power of attorney, over company “Impel” d.o.o., registered in the Business Registers Agency of the Republic of Serbia under company number 08594864, with registered seat at the address 53a Žarka Zrenjanina St., Zrenjanin, Republic of Serbia, as a concentration previously not approved by the Commission, on the 151<sup>st</sup> session held on July 12, 2013, Council of the Commission for Protection of Competition enacts the following

## **DECISION**

**I** Concentration of undertakings in investigation procedure **IS APPROVED** created pursuant to the change of a form of control over company “Impel” d.o.o., registered in the Business Registers Agency of the Republic of Serbia under company number 08594864, with registered seat at the address 53a Žarka Zrenjanina St., Zrenjanin, Republic of Serbia, transformed from the previous individual control, pursuant to the implementation of this concentration, into joint control over company “Impel” d.o.o., implemented on the part of company „Autoritas Investments“ d.o.o. Novi Sad, with registered seat at the address 41 Kosovska St., registered in the Business Registers Agency of the Republic of Serbia under company number 20432730, and natural person Dragan Vidaković, founder and previous sole shareholder and owner of the target company.

**II** **COMMITMENT IS ESTABLISHED** against company „Autoritas Investments“ d.o.o. Novi Sad, relating to the issuance of a decision on the approval of concentration in investigation procedure conducted in *ex officio* proceedings by the Commission, to execute payment in the amount of EUR 50,000.00 (in words: fifty thousand euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, or appropriate dinar-currency equivalent value of said amount to the dinar-currency account of the

Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance and Economy, calculated at the middle exchange rate of the National Bank of Serbia on the day of payment.

**III IT IS ESTABLISHED** that company „Autoritas Investments“ d.o.o. Novi Sad has executed payment in the amount of RSD 2,765,695.00 (in words: two million, seven hundred sixty-five thousand, six hundred ninety-five and 00/100 dinars) on May 20, 2013 to the dinar-currency account of the Commission for Protection of Competition no. 840-0000000880668-16 maintained with the Treasury Administration of the Ministry of Finance and Economy, which represents appropriate dinar-currency value of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.

**IV COMMITMENT IS ESTABLISHED** against company „Autoritas Investments“ d.o.o. Novi Sad to execute payment of the remaining amount of fee as compensation from Paragraph II of the enacting terms herein, that is, to execute payment in the amount of EUR 25,000.00 (in words: twenty-five thousand euro) to the foreign-currency account of the Commission or appropriate dinar-currency equivalent value of said amount to the dinar-currency account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance and Economy, calculated at the middle exchange rate of the National Bank of Serbia on the day of payment, within a period not exceeding ten days following the receipt of this decision.
