Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09), Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), and Article 13(2) of the Statute of the Commission for Protection of Competition (Official Gazette of the RS 49/2010), deciding under the Notification of concentration entered under number 6/0-02-348/2013-1, submitted on behalf of the client, company „Telenor Mobile Communications AS“, with registered seat at the address Snaroyveien 30D, 1331 Fornebu, Norway, company number 963815840, pursuant to the presented Power of attorney by Srđana Petronijević, attorney at law from Belgrade, 27 Francuska St., on June 13, 2013, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-332/2013-2 of May 29, 2013, enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of company „Telenor Mobile Communications AS“, with registered seat at the address Snaroyveien 30D, 1331 Fornebu, Norway, registered in the Brønnøysund Register Centre under company number 963815840, over companies „Cosmo Bulgaria Mobile EAD“, company number 130460283 and „Germanos Telecom Bulgaria EAD“, company number 130276112, both registered in the Bulgarian business register which is administered by the Registry Agency attached to the Ministry of Justice of the Republic of Bulgaria, with identical registered seats at the address, Business park Sofia, Mladost 4, Building 6, Sofia, Bulgaria, created pursuant to the contractual takeover of all shares in target companies from their previous owner, Greek telecommunication operator Hellenic Telecommunications Organization SA (OTE).

**II IT IS ESTABLISHED** that the Party in timely manner executed payment in the amount of RSD 2,768,147.50 (in words: two million, seven hundred sixty-eight thousand, one hundred forty-seven and 50/100 dinars) to the account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance and Economy of the Republic of Serbia, with reference number 6/0-02-348/2013-1, which represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
