Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09), Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), and Article 13(2) of the Statute of the Commission for Protection of Competition (Official Gazette of the RS 49/2010), deciding under the notification of concentration entered under number 6/0-02-434/2013-1, submitted on behalf of clients, company „Agrifirm Group B.V.“, with registered seat at the address Landgoedlaan 20, Apeldoorn, the Netherlands, incorporated and organized in accordance with the legislation of the Netherlands and registered in the Dutch Chamber of Commerce and Industry under company number 50003631, and natural person Zoran Vukadinović, citizen of the Republic of Serbia, passport number 007180340, UPIN 3007963710009, with registered residency at the address 3 March 27<sup>th</sup> St., Belgrade, Republic of Serbia, pursuant to the presented Power of attorney by Ivana Ajdanić and Ana Banićević, attorneys at law from Belgrade, 6 Mihaila Pupina Blvd., BC Ušće, 24<sup>th</sup> floor, on June 26, 2013, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-332/2013-3 of May 29, 2013, enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of company “Agrifirm Group B.V.“, with registered seat at the address Landgoedlaan 20, Apeldoorn, the Netherlands, incorporated and organized in accordance with the legislation of the Netherlands and registered in the Dutch Chamber of Commerce and Industry under company number 50003631, and natural person Zoran Vukadinović, citizen of the Republic of Serbia, passport number 007180340, UPIN 3007963710009, with registered residency at the address 3 March 27<sup>th</sup> St., Belgrade, Republic of Serbia, over company Preduzeće za preradu prehrambenih proizvoda i trgovinu na veliko i malo „Sto posto“ d.o.o. Beograd, incorporated and organized in accordance with the legislation of the Republic of Serbia, with registered seat at the address 112-120/III Cvijićeve St., Belgrade-Palilula, Republic of Serbia, registered in the Business Registers Agency of the Republic of Serbia under company number 17280864, in a manner where “Agrifirm Group B.V.“ acquires 35% shares in company „Sto posto“ d.o.o. Beograd by way of recapitalization, pursuant to which will execute joint control over said company with the previous exclusive owner.

**II IT IS ESTABLISHED** that the Parties in timely manner have executed payment in the amount of EUR 24,973.00 (in words: twenty-four thousand, nine hundred seventy-three and 00/100 euro) to the foreign-currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, and amount of RSD 3,090.00 (in words: three thousand, ninety and 00/100 dinars) to the dinar-currency account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance and Economy of the Republic of Serbia, which in total represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
