Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09), Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), and Article 13(2) of the Statute of the Commission for Protection of Competition (Official Gazette of the RS 49/2010), deciding under the notification of concentration entered under number 6/0-02-443/2013-1 of June 19, 2013, submitted on behalf of the client, company STEINHOFF INTERNATIONAL HOLDINGS LIMITED, with registered seat in the South African Republic at the address 28 28 Sixth Street, Wznberg, Sandton 2090, registered under company number 1998/003951/06, pursuant to the presented Power of attorney by Maja Stanković from the Law Office “Wolf Theiss”, BC Ušće, 6 Mihajla Pupina Blvd., New Belgrade, on July 12, 2013, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-332/2013-4 of May 29, 2013, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of control on the part of company STEINHOFF INTERNATIONAL HOLDINGS LIMITED, with registered seat in the South African Republic at the address 28 28 Sixth Street, Wznberg, Sandton 2090, registered under company number 1998/003951/06, over company RUDOLF LEINER GESELLSCHAFT M.B.H., with registered seat at the address Porschesstraße 7, 3100 St. Pölten, Republic of Austria, registered in the business entities register under company number FN 94579 m, and over company LKM BETEILIGUNGSGESELLSCHAFT M.B.H., with registered seat at the address Anton-Scheiblin-Gasse 1, 3100 St. Pölten, Republic of Austria, registered in the business entities register under company number FN 92668 b, pursuant to the Share purchase agreement, regulating the purchase of all shares in these companies from current shareholders which as affiliated undertakings belong to the identical group of companies.

II IT IS ESTABLISHED that the Party in timely manner executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand and 00/100 euro) to the foreign currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, with reference number 6/0-02-443/2013-1, which represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
