Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09), Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 47/2011), and Article 13(2) of the Statute of the Commission for Protection of Competition (Official Gazette of the RS 49/2010), deciding under the Notification of concentration entered under number 6/0-02-445/2013-1, submitted on behalf of the Parties, company „SECAR Technologie GmbH“, with registered seat at the address Industriepark 14, 8682 Murzzuschlag – Honigsberg, Austria, registered in the Leoben Regional Court, Austria, under company registration number FN 174528, and company „Evonik International Holding B.V.“, with registered seat at the address Hettenheuvelweg 37 t/m 39,1101 BM Amsterdam Zuidoost, the Netherlands, registered in the Trade Register maintained by the Chamber of Commerce and Industry of Amsterdam under company registration number 34391436, pursuant to the presented individual Powers of attorney by Bojan Vučković, attorney at law from Belgrade, 23 Resavska St., on July 11, 2013, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-332/2013-4 of May 29, 2013, enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created pursuant to the change of a form of control over company „LiteCon GmbH“, with registered seat at the address Industriepark 14, 8682 Murzzuschlag - Honigsberg, Austria, registered in the Leoben Regional Court, Austria, under company registration number FN 395469, whereby previous individual control over this company executed on the part of company „SECAR Technologie GmbH“, with registered seat at the address Industriepark 14, 8682 Murzzuschlag – Honigsberg, Austria, registered in the Leoben Regional Court, Austria, under company registration number FN 174528, following the implementation of related concentration based on the partial takeover of shares in company „LiteCon GmbH“, is transformed into joint control executed over the target company by company „Evonik International Holding B.V.“, with registered seat at the address Hettenheuvelweg 37 t/m 39,1101 BM Amsterdam Zuidoost, the Netherlands, registered in the Trade Register maintained by the Chamber of Commerce and Industry of Amsterdam under company registration number 34391436.

**II IT IS ESTABLISHED** that the Parties in timely manner executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand and 00/100 euro) to the foreign currency account of the Commission for Protection of Competition maintained with the National Bank of Serbia, with reference number 6/0-02-445/2013-1, which represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition.
