Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09), Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), and Article 13(2) of the Statute of the Commission for Protection of Competition (Official Gazette of the RS 49/2010), deciding under the notification of concentration entered under number 6/0-02-487/2013-1, submitted on behalf of the client, company "LUKOIL Lubricants Austria GmbH", incorporated in accordance with the legislation of Austria, with registered seat in Vienna, Schwarzenbergplatz 6, registered in the Commercial Court in Vienna under company number FN 396834 f, pursuant to the presented Power of attorney by Raško Radovanović, attorney at law from Belgrade, 13a Zmaja od Noćaja St., on August 7, 2013, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-332/2013-5 of May 29, 2013, enacts the following

DECISION
