Pursuant to Article 37(2) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), Article 192(1) of the Law on General Administrative Procedure (Official Gazette of the FRY 33/97 and 31/01, and Official Gazette of the RS 30/2010), Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), and Article 13(2) of the Statute of the Commission for Protection of Competition (Official Gazette of the RS 49/2010), deciding under the notification on concentration entered under the reception number 6/0-02-688/2015-1 of September 16, 2015, submitted on the part of company “Preduzeće za proizvodnju i promet Industrija mesa Matijević d.o.o.“, with registered seat at the address 86 Rumenački put St., Novi Sad, registered in the Business Registers Agency of the Republic of Serbia under company registration number 08588759, on October 2, 2015, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the President of the Commission for Protection of Competition no. 1/0-06-554/2015-4 of October 1, 2015, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of control on the part of company “Preduzeće za proizvodnju i promet Industrija mesa Matijević d.o.o.“ from Novi Sad, with registered seat at the address 86 Rumenački put St., registered in the Business Registers Agency of the Republic of Serbia under company registration number 08588759, over company “Poljoprivreda” a.d. – in liquidation from Senta, with registered seat at the address 25 Poštanska St., registered in the Business Registers Agency of the Republic of Serbia under company registration number 08137161, created pursuant to the implemented procedure of the sale of bankruptcy debtor - company “Poljoprivreda” a.d. – in liquidation, by public tendering procedure.

II IT IS ESTABLISHED that company “Preduzeće za proizvodnju i promet Industrija mesa Matijević d.o.o.“ as an applicant of notification on concertation concerned, has performed on its obligation to pay a fee as a compensation for issuing this decision, by executing payment in the amount of RSD 3,003,302.50 (in words: three million, three thousand, three hundred two and 50/100 dinars) to the dinar-currency account of the Commission for Protection of Competition maintained with the Treasury Administration of the Ministry of Finance with reference number 6/0-

02-688/2015-1, which represents determined dinar-currency equivalent value of the regulated fee as compensation for issuing decision on approval of concentration in summary procedure from Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition, calculated by implementing the middle exchange rate of the National Bank of Serbia on the day of payment.
