Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensation for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification of concentration entered under number 6/0-02-388/2017-1, submitted by company Mercur Casino GmbH Austria, with registered seat in Austria at the address Seilerstatte 22, Vienna, Aleksandar Jojić, with permanent residence in Belgrade at the address 43 Trebevićka St., and Miroslav Sarić, with permanent residence in Novi Sad at the address 16 Lovćenska St., jointly represented by procurator holder, attorney at law Nikola Poznanović from Belgrade, 6 Vladimira Popovića St., on June 12, 2017, a member of the Council of the Commission for Protection of Competition acting upon the authority granted by the Commission President no. 1/0-06-165/2017-10 of June 2, 2017, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of company Mercur Casino GmbH Austria, with registered seat in Austria at the address Seilerstatte 22, Vienna, registered in the Austrian Business Register under company number FN 289690s, Aleksandar Jojić, with permanent residence in Belgrade at the address 43 Trebevićka St., unique personal identification number 0508970710012, and Miroslav Sarić, with permanent residence in Novi Sad at the address 16 Lovćenska St., unique personal identification number 2301965880027, over company Merkur Games d.o.o. Beograd, with registered seat in Belgrade at the address 64 Mileševska St., registered in the Business Registers Agency of the Republic of Serbia under company number 20781335, created by changing the individual form of control into joint control in a manner where company Mercur Casino GmbH Austria, as the previous sole shareholder, keeps 51% shares, while Aleksandar Jojić and Miroslav Sarić acquire 24.5% shares each.

II IT IS ESTABLISHED that the Parties, company Mercur Casino GmbH Austria, Aleksandar Jojić and Miroslav Sarić, have executed payment in full as compensation for issuing this decision, by paying the stipulated amount to the account of the Commission for Protection of Competition in the following manner: company Mercur Casino GmbH Austria has executed

payment in the amount of EUR 12,750.00 (in words: twelve thousand, seven hundred fifty euro) on May 16, 2017, Aleksandar Jojić has executed payment in the amount of RSD 754,470.00 (in words: seven hundred fifty-four thousand, four hundred seventy dinars) on May 17, 2017, while Miroslav Sarić has executed payment in the amount of RSD 754,266.80 (in words: seven hundred fifty-four thousand, two hundred sixty-six and 80/100 dinars) on May 18, 2017, which is equal in total to EUR 25,000.00 (in words: twenty-five thousand euro).
