Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification on concentration entered under number 6/0-02-640/2017-1 of October 6, 2017, submitted by company „Robert Bosch“ GmbH, with registered seat at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhöhe, Germany, and company „HUAYU Automotive Systems Company“ Ltd., with registered seat at the address 489 Wei Hai Road, Shanghai, People’s Republic of China, via attorney at law Srđana Petronjević from the Law Office „Moravčević Vojnović & Partneri“ from Belgrade, 15 Dobračina St., on November 10, 2017, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of company „Robert Bosch“ GmbH, with registered seat at the address Robert-Bosch-Platz 1, 70839 Gerlingen-Schillerhöhe, Germany, company number HRB 14000, and company „HUAYU Automotive Systems Company“ Ltd., with registered seat at the address 489 Wei Hai Road, Shanghai, People’s Republic of China, company number 00000000201709080056, via their jointly owned company „Bosch HUAYU Steering Systems Co.”, Ltd., with registered seat at the address 2001, Yongsheng Road, Jiading Industrial Zone, Shanghai, People’s Republic of China, company number 0000000220160704003, over company „Bosch Automobile Steering (Nanjing) Co.”, Ltd., with registered seat at the address No. 1 Lianxi Road, Economic and Technology Development Zone Nanjing, People’s Republic of China, company number 320100400054108, by acquiring 100% of shares.

II **IT IS ESTABLISHED** that the applicants executed payment in the amount of RSD 2,980,557.50 (in words: two million, nine hundred eighty thousand, five hundred fifty-seven and 50/100 dinars) on October 17, 2017, to the account of the Commission for Protection of Competition, which represents stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
