Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification on concentration entered under number 6/0-02-154/2018-1 of January 22, 2018 submitted by company Sigma Bidco B.V., with registered seat at the address Overschiestraat 61, 5 hoog, 1062 XD Amsterdam, the Netherlands, company number 70298807, via attorney at law Anja Tasić from the Law Firm Petrikić & Partneri from Belgrade, 3 Cincar Jankova St., on February 20, 2018, President of the Commission for Protection of Competition enacts the following

### **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of indirect control on the part of company KKR & Co. L.P., with registered seat at the address 1209 Orange Street, Wilmington, New Castle County, Delaware 19801, United States of America, via its subsidiary company Sigma Bidco B.V., with registered seat at the address Overschiestraat 61, 5 hoog, 1062 XD Amsterdam, the Netherlands, company number 70298807, over companies: 1. Unilever BCS Holdings B.V., incorporated and operative in accordance with the legislation of the Netherlands, with registered seat at the address Weena 455, 3013 AL Rotterdam, the Netherlands, company number 63235528 and its subsidiaries, 2. Unilever BCS IP Deutschland GmbH & Co OHG, incorporated and operative in accordance with the legislation of Germany, with registered seat at the address Am Strandkai 1, 20457 Hamburg, Germany, company number HRA 119030, 3. Unilever BCS Deutschland Immobilien Leasing GmbH & Co OHG, incorporated and operative in accordance with the legislation of Germany, with registered seat at the address Am Strandkai 1, 20457 Hamburg, Germany, company number HRA 119032, 4. Elanthi S.A., incorporated and operative in accordance with the legislation of Greece, with registered seat at the address Kymis Avenue & 10, Seneka St., Kifissia, Greece, company number 007927801000, and which are in the indirect ownership by company Unilever N.V., with registered seat at the address Weena 455, 3013 AL Rotterdam, the Netherlands, company number 24051830 and company Unilever Plc, with registered seat at the address Port Sunlight, Wirral, Merseyside, CH62 4ZD, United Kingdom, company number 41424, executed by acquiring 100% of shares or stocks, as well as operating activities in the area of bread-making and cookery encompassing baking, cooking and spread production services.

**II IT IS ESTABLISHED** that the Party, Sigma Bidco B.V., with registered seat at the address Overschiestraat 61, 5 hoog, 1062 XD Amsterdam, the Netherlands, company number 70298807, executed payment in the amount of RSD 2,966,367.50 (in words: two million, nine hundred sixty-six thousand, three hundred sixty-seven and 50/100 dinars) on January 24, 2018 to the account of the Commission for Protection of Competition, which represents stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
