Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification of concentration entered under number 6/0-02-279/2018-1 of March 16, 2018, submitted by companies „Mino Investments Limited“, with registered seat at the address Tudor House, 2<sup>nd</sup> floor, Le Bordage, St. Peter Port, Guernsey GY1 1BT, „MediCap Health Group“ S.à r.l., with registered seat at the address 20 rue de la Poste, 2346 Luxembourg, Luxembourg, and „Klinika Miloš“ B.V., with registered seat at the address Naritaweg 165, Telestone 8, 1043BW Amsterdam, the Netherlands, via a procurator holder, attorney at law Bojan Vučković from the Law Office „Karanović i Nikolić“, 23 Resavska St., Belgrade, on May 3, 2018, President of the Commission for Protection of Competition enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of companies „Mino Investments Limited“, with registered seat at the address Tudor House, 2<sup>nd</sup> floor, Le Bordage, St. Peter Port, Guernsey GY1 1BT, company number 64617, „MediCap Health Group“ S.à r.l., with registered seat at the address 20 rue de la Poste, 2346 Luxembourg, Luxembourg, company number B221229, and „Klinika Miloš“ B.V., with registered seat at the address Naritaweg 165, Telestone 8, 1043BW Amsterdam, the Netherlands, company number 60256109, over a company that needs to be created and which will execute control over companies „MediGroup SEE“ d.o.o., with registered seat at the address 26 Pariske komune St., Belgrade, company number 20952881, and „Personal Vision“ d.o.o., with registered seat at the address 1-3 Andre Nikolića St., Belgrade, company number 21006599, implemented in a manner where company „Mino Investments Limited“ acquires 55% of shares in the newly founded company, while companies „MediCap Health Group“ and „Klinika Miloš“, as previous sole shareholders, jointly retain 45% interest as affiliates.

**II IT IS ESTABLISHED** that the Parties, companies „Mino Investments Limited“, „MediCap Health Group“ S.à r.l., and „Klinika Miloš“ B.V., have executed payment in the amount of RSD 2,955,510.00 (in words: two million, nine hundred fifty-five thousand, five hundred ten dinars) on April 11, 2018 to the account of the Commission for Protection of Competition, which

represents appropriate amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
