Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the notification of concentration entered under number 6/0-02-381/2018-1, submitted by companies Mitsui & Co. Ltd., with registered seat at the address 1-3 Marunouchi 1-chome, Chiyoda-ku, Tokyo, 100-8631, Japan, and Kansai Paint Co. Ltd., with registered seat at the address 6-14, Imabashi 2-chome, Chuo-ku, Osaka, 541-8523, Japan, represented by a procuration holder, attorney at law Tijana Kojović from Belgrade, 28 Kralja Aleksandra Blvd., on May 22, 2018, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of companies Mitsui & Co. Ltd., with registered seat at the address 1-3 Marunouchi 1-chome, Chiyoda-ku, Tokyo, 100-8631, Japan, company registration number 0100-01-008767, and Kansai Paint Co. Ltd., with registered seat at the address 6-14, Imabashi 2-chome, Chuo-ku, Osaka, 541-8523, Japan, company registration number 1400-01-048243, over company Kansai Helios Coatings GmbH, with registered seat at the address Ignaz Kock-Strasse 15, 1210 Vienna, Austria, company registration number FN 258099h, created by changing individually executed control by company Kansai Paint Co. Ltd. into jointly executed control.

II IT IS ESTABLISHED that the Parties, companies Mitsui & Co. Ltd. and Kansai Paint Co. Ltd., both with corporate seats in Japan, have executed respective payment in full as compensation for issuing this decision, by paying the amount equivalent to RSD 2,954,680.00 (in words: two million, nine hundred fifty-four thousand, six hundred eighty dinars) to the account of the Commission for Protection of Competition on May 7, 2018, which corresponds to the dinar-currency value of EUR 25,000.00 (in words: twenty-five thousand euro) calculated at the middle exchange rate of the National Bank of Serbia on the day of payment.
