Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification on concentration entered under number 6/0-02-806/2017-1 of December 28, 2017, submitted by company Naftna industrija Srbije a.d. Novi Sad, with registered seat at the address 12 Narodnog fronta St., Novi Sad, Serbia, company number 20084693, via authorized representative Tomislav Petković, an employee of Naftna industrija Srbije a.d. Novi Sad in charge of the Department for asset transformation from Belgrade, 1 Miletija Popovića St., Belgrade, on January 9, 2018, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of control on the part of company Naftna industrija Srbije a.d. Novi Sad, with registered seat at the address 12 Narodnog fronta St., Novi Sad, Serbia, company number 20084693, over parts of other undertaking, company Eurostar d.o.o. Niš, with registered seat at the address bb Toponički put St., 18000 Niš, Serbia, company number 17552333, which may represent an independent business entirety, specifically over the following petrol stations: 1. Petrol station “Čele kula”, bb Vojvode Mišića St., Niš, erected on cadastral plots number 152/2 and 152/9 of the Cadastral municipality of Čele kula, entered into the real estate folio in the land register under number 2409 CM Čele kula, and 2. Petrol station “Crveni krst”, 12th February Blvd., Niš, erected on cadastral plots number 60/1, 68/2, 69, 70, 60/4, 60/5, 71/1, 68/1, 60/6 and 60/2 of the Cadastral municipality of Crveni krst, entered into the real estate folio in the land register under number 1223, cadastral plot number 71/2, entered into the real estate folio in the land register under number 2503, and cadastral plot 68/3, entered into the real estate folio in the land register under number 1365.

II IT IS ESTABLISHED that the Party, company Naftna industrija Srbije a.d. Novi Sad, with registered seat at the address 12 Narodnog fronta St., Novi Sad, Serbia, company number 20084693, executed payment in the amount of RSD 2,969,892.50 (in words: two million, nine hundred sixty-nine thousand, eight hundred ninety-two and 50/100 dinars) on January 8, 2018 to the account of the Commission for Protection of Competition, which represents stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
