Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification of concentration entered under number 6/0-02-413/2018-1 of May 21, 2018, submitted by companies Generali CEE Holding B.V., with registered seat at the address Diemerhof 42, 1112 XN Diemen, Amsterdam, the Netherlands, and Generali Życie Towarzystwo Ubezpieczeń S.A., with registered seat at the address Polandul, Postępu 15B, 02-676, Warsaw, Poland, via a procuration holder, attorney at law Anja Tasić from the Law Office of Petrikić & Partneri, Belgrade, 73 Krunska St., on June 8, 2018, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of indirect control on the part of company Assicurazioni Generali S.p.A., with registered seat at the address Piazza Duca degli Abruzzi 2 CAP 34132, Trieste, Italy, company number 00079760328, via its subsidiary companies Generali CEE Holding B.V., with registered seat at the address Diemerhof 42, 1112 XN Diemen, Amsterdam, registered in the Dutch Chamber of Commerce under company number 34275688, and Generali Życie Towarzystwo Ubezpieczeń S.A., with registered seat at the address Polandul, Postępu 15B, 02-676, Warsaw, Poland, registered in the Register of Entrepreneurs of the National Court Register maintained by the District Court for the Capital City of Warsaw under company number KRS 25952, over companies Concordia Polska Towarzystwo Ubezpieczeń Wzajemnych, with registered seat at the address Stanisława Małachowskiego 10, 61-129 Poznan, Poland, registered in the Register of Entrepreneurs of the National Court Register maintained by the District Court for the City of Poznan under company number KRS 0000083521, and Wielkopolskie Towarzystwo Ubezpieczeń Życiowych i Rentowych Concordia Capital S.A., with registered seat at the address Stanisława Małachowskiego 10, 61-129 Poznan, Poland, registered in the Register of Entrepreneurs of the National Court Register maintained by the District Court for the City of Poznan under company number KRS 0000020536, by purchasing shares.

II IT IS ESTABLISHED that the Parties have executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand and 00/100 euro) on May 23, 2018 to the account of the

Commission for Protection of Competition, which represents stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
