Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification of concentration entered under number 6/0-02-436/2018-1 of May 28, 2018, submitted by company S&T AG, with registered seat at the address Industriezeile 35, 4021, Linz, Austria, via a procuration holder, attorney at law Maja Stanković from the Law Office Wolf Theiss from Belgrade, 6 Mihajla Pupina Blvd., on June 15, 2018, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of direct control on the part of company S&T AG, with registered seat at the address Industriezeile 35, 4021, Linz, Austria, company number FN 190272m, over companies: 1. Kapsch EOOD, with registered seat at the address Kukush 2, Business Park Antim Tower, 3rd floor, Sofia, Bulgaria, company number 131576970; 2. II IT IS ESTABLISHED that the Party, company S&T AG, has executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand and 00/100 euro) on May 30, 2018 to the account of the Commission for Protection of Competition, which represents stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
