Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the Notification of concentration entered under number 6/0-02-496/2018-1 of June 21, 2018, submitted by company Baunit GmbH, with registered seat at the address Reckenberg 12, 87541 Bad Hindelang, Germany, via procurator holder, attorney at law Danijel Stevanović and others from the Law Firm of Moravčević, Vojnović & Partners from Belgrade, 15 Dobračina St., on August 6, 2018, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of control on the part of company Baunit GmbH, with registered seat at the address Reckenberg 12, 87541 Bad Hindelang, Germany, company number HRB 9558, over the following companies: Krusemark Edelputz GmbH & Co. KG, with registered seat at the address Industriestraße 25-27, 63165 Mühlheim am Main, Germany, company number HRA 6499; Krusemark Schaefer Verwaltungs GmbH, with registered seat at the address Industriestraße 25-27, 63165 Mühlheim am Main, Germany, company number HRB 3731; Schaefer Krusemark GmbH & Co. KG, with registered seat at the address Louise-Seher-Straße 6, 65582 Diez, Germany, company number HRA 3896; Schaefer Krusemark Vertriebs GmbH, with registered seat at the address Louise-Seher-Straße 6, 65582 Diez, Germany, company number HRB 6022; and, K+S Handelsgesellschaft für Maler- und Putzerbedarf mbH, with registered seat at the address Industriestraße 25-27, 63165 Mühlheim am Main, Germany, company number HRB 5223, by acquiring 100% of shares in companies Krusemark Edelputz, Krusemark Schaefer Verwaltungs, K+S Handelsgesellschaft für Maler - und Putzerbedarf, and 75% of shares in companies Schaefer Krusemark and Schaefer Krusemark Vertriebs, as well as by acquiring real-estate qualified as “Commercial property Mühlheim”, entered into the Mühlheim Land Registry maintained by the Basic Court in Offenbach am Main, land register folio 5966, and “Arondation land Mühlheim”, land register folio 11495.

II IT IS ESTABLISHED that the Party has executed payment in the amount of EUR 25,000.00 (in words: twenty-five thousand euro) on June 28, 2018, to the account of the

Commission for Protection of Competition, which represents a stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
